

BRIEF FACTS OF THE CASE

- (1) That the appellant has filed an application dated 24-04-2015 (Annexure -
 - 1) under Section 6 of the RTI Act, 2005 requesting for the following information:
 - (A) It is learnt that the CESTAT Members Conference / Meeting is going to be held in Mumbai in May, 2015. In this respect, please provide the following information:
 - (i) Please provide the file number from which the proposal for holding the aforesaid Members Conference / Meeting is proposed and provide copies of all notesheets and correspondence pages of the said file.
 - (ii) Please provide details as to the total expenditure involved (including for Tour & Travel).
 - (iii) Please provide details of the Venue of aforesaid conference / meeting and the names of the officials including Customs and Excise Officials and the Lawyers, who are making arrangements for the aforesaid conference / meeting.
 - (iv) Please provide details of the source of fund and the accounting head from which the expenses for the aforesaid conference / meeting has been made / are being made.
 - (v) Please provide details of the approval of the Ministry of Finance for holding the said conference / Meeting at Mumbai instead of at CESTAT Headquarters at Delhi.
 - (vi) Please provide copies of the agenda points and purpose of holding these conferences/ meetings at Mumbai instead of CESTAT Headquarters at Delhi.
 - (B) Please provide details of the last three CESTAT Members Conferences / Meetings with their location and the amount spent on the said conferences / meetings. Please also provide information and copies of the documents about the outcome of the said conferences / meetings.
- (2) That the appellant vide para 5 of his said application has also made a declaration that the information sought for is not exempted under Section 8 or 9 of the RTI Act, 2005 and also stated that to the best of the knowledge of the appellant, the information pertains to the Office of the CPIO in question.

(3) That the appellant received letter dated 27-4-2015 (Annexure-2) of the CPIO to A.R.(Admn.) & Registrar. The Appellant vide letters dated 29-4-2015 (Annexure-3) requested the said authorities to provide the desired information within the period of 30 days as stipulated under Section 7(1) of the RTI Act, 2005. The Appellant has neither received any information nor any response from the said authority therefore, as per Section 7(2) of the RTI Act, 2005, the request for information shall be deemed to have been refused. Thus being aggrieved by such refusal, this Appeal.

GROUNDS OF APPEAL

- (1) That the action of the learned CPIO and the deemed CPIO in not providing the information to the appellant is illegal and contrary to the provisions and sprit of the RTI Act, 2005.
- (2) That the information sought by the appellant is not exempted under Section 8 or 9 or any other provisions of the RTI Act, 2005 and therefore, there was no valid cause or reason or ground for not providing the information.
- (3) That the inaction of CPIO & Deemed CPIOs is in violation of Sections 7(1) and 7(2) of the RTI Act, 2005 and is therefore, illegal. Such inaction is deemed to be a refusal to the request of the appellant without any reasonable cause or ground hence is illegal.
- (4) That the information sought is neither voluminous nor relate to older and larger period, thus could have easily been provided by the learned CPIO.
- (5) That the appellant is citizen of India and fulfilled all other requirements of the RTI Act and the Rules made thereunder and is entitled to the information in question.
- (6) That as per proviso to Section 8(1) of the RTI Act, 2005, the information which can not be denied to the Parliament or the State Legislatures shall not be denied to any person. The information sought by the appellant in the subject application is the one which cannot be denied to the Parliament or the State Legislatures and hence it cannot be denied or refused to the appellant.



- (7) This is without prejudice to the right of the appellant to add, alter or modify any of the grounds of this appeal and adduce oral or written evidence at the time of hearing.
- (8) That a personal hearing may be granted to the appellant before deciding the present appeal.
- (9) This is without prejudice to the right of the appellant to add, alter or modify any of the grounds of this appeal and adduce oral or written evidence at the time of hearing or till the appeal is disposed of.

PRAYER

Under the circumstances, the appellant prays as under:

- (a) That the Original Records may be summoned and perused.
- (b) That the CPIO may be directed to provide the information in question within a time bound frame.
- (c) That any other relief as the Appellate Authority deem fit and proper may also be ordered in favour of the appellant.
- (d) That a personal hearing may be granted to the appellant before deciding the appeal.

BRIEF FACTS OF THE CASE

- (1) That the appellant has filed an application dated 17-10-2013 (Annexure 1) under Section 6 of the RTI Act, 2005 requesting for the following information:
 - (A) Please provide details of the implementation of the direction issued in para 1.4.1 of the Guidelines enclosed with Office Memoranda No. 1/6/2011-IR, dated 15 April 2013 of the DOPT regarding proactive disclosure of RTI applications, appeals received and their responses on your website with search facility based on keyword.
 - (B) Provide copy of the Action Taken Report submitted on the compliance of the Guidelines issued under Office Memoranda No. 1/6/2011-IR, dated 15 April 2013 of DOPT, as required under para 4.3 of the said Guidelines
 - (C) Provide datewise details of the action taken by your public authority in relation to paragraph 4.1, 4.2, 4.4 and 4.7 of the aforesaid Guidelines of the DOPT and copies of all notesheets & correspondence
 - (D) Please provide datewise details of the compliance of para 3.6 of the aforesaid Guidelines.
 - (E) Please provide list of directions given in the aforesaid Guidelines which have not so far been implemented/operationalised by you till 17.10.2013 and expected date by which each one of them is expected to be implemented.
 - NOTE:- As per paragraph 4.1 of the aforesaid guidelines all public authorities, including CIC is to make the aforesaid guidelines fully operationalised within a period of six-month, the said period of six-month has expired on 15th of October 2013, as the guidelines in question were issued on 15 April 2013.
- (2) That the appellant vide para 5 of his said application has also made a declaration that the information sought for is not exempted under Section 8 or 9 of the RTI Act, 2005 and also stated that to the best of the knowledge of the appellant, the information pertains to the Office of the CPIO in question.

(3) That the CPIO and the Deemed CPIO have deliberately and malafidely provided incomplete and incorrect information despite point-wise specific information sought by the Appellant. The appellant being aggrieved by the said order of the CPIO is filling the present appeal.

GROUNDS OF APPEAL

- (1) That the order in question of the CPIO is incorrect and illegal and contrary to the provisions and sprit of the RTI Act, 2005 hence liable to be set aside.
- (2) That the information sought by the appellant is not exempted under Section 8 or 9 or any other provisions of the RTI Act, 2005, therefore, there was no valid cause or reason or ground for not providing the information.
- (3) That the CPIO and the Deemed CPIO are deliberately and malafidely not provided complete and correct information, inasmuch as the information is transmitted in May, 2015 but it contains information only up to October December, 2014. Therefore, the CPIO may be directed to provide up-to-date information within time bound frame.
- (4) That the CPIO and the Deemed CPIO are deliberately and malafidely not provided complete and correct information, inasmuch they have withheld the information in relation to Mrs. Archana Wadhwa, Member (J), Shri H.K. Thakur, Member (T) and Shri P.K. Jain, Member (T). Therefore, the CPIO may be directed to provide up-to-date information within time bound frame.
- (5) That the CPIO has erred in not providing the information to the appellant though as per the provisions of the RTI Act, the appellant is entitled to information as sought by him. Therefore, the order of the CPIO is liable to be set aside with direction to provide the information to the appellant within time bound frame.
- (6) That the information sought is neither voluminous nor relate to older and larger period, thus could have easily been provided by the learned CPIO.
- (7) That as per proviso to Section 8(1) of the RTI Act, 2005, the information which can not be denied to the Parliament or the State Legislatures shall not be denied to any person. The information sought by the appellant in

the subject application is the one which cannot be denied to the Parliament or the State Legislatures and hence it cannot be denied or refused to the appellant.

- (8) That a personal hearing may be granted to the appellant before deciding the present appeal.
- (9) This is without prejudice to the right of the appellant to add, alter or modify any of the grounds of this appeal and adduce oral or written evidence at the time of hearing or till the appeal is disposed of.

PRAYER

Under the circumstances, the appellant prays as under:

- (a) That the Original Records may be summoned and perused.
- (b) That the order of the CPIO may be set aside to the extent it has been appealed against and CPIO/Deemed CPIOs may be directed to provide the information in question within time bound frame.
- (c) That imposition of penalty may also be recommended against the CPIO for not providing the complete and correct information.
- (d) That any other relief as the Appellate Authority deem fit and proper may also be ordered in favour of the appellant.
- (e) That a personal hearing may be granted to the appellant before deciding the appeal.

- (2) That the information sought by the appellant is not exempted under Section 8 or 9 or any other provisions of the RTI Act, 2005, therefore, there was no valid cause or reason or ground for not providing the information.
- (3) That the CPIO has not provided complete and correct information inasmuch as complete information has not been provided for Point (A), (C), (D) & (E) of the RTI Application. Therefore, the order of the CPIO in this respect is incorrect and illegal and liable to be set aside and the CPIO be directed to provide the information in time bound frame.

- (1) That the appellant has filed an application dated 01-06-2015 (Annexure -
 - 1) under Section 6 of the RTI Act, 2005 requesting for the following information:
 - (A) Please provide date-wise details of Air/Rail tickets purchased/procured for the air travel/rail travel by CESTAT from 01-04-2013 till the date of providing the information.
 - (B) Please provide copies of Bills received from Balmer Lawrie either for purchase/ procurement of tickets in credit/cash from 01-04-2013 till the date of providing the information and provide certified copies of those bills and list of bills which has not been paid so far.
 - (C) Please provide certified copies of all tour proposals/requests whether approved or rejected, tour orders, tour programmes, itineraries and protocols requests in relation to Hon'ble President, Members, Registrar and for others staff members of CESTAT and including for Members' Conference held at Mumbai in 2015.
 - (D) Please provide date-wise details of amount spent on tour and travel by CESTAT including for air tickets from 01-04-2013 till the date of providing the information.
 - (E) Please provide details of amount spent by CESTAT for cancellation of air/rail tickets from 01-01-2013 till the date of providing the information.
 - (F) Please provide date-wise details of cases where CESTAT has paid for the travel but journey has not been undertaken from the period 01-04-2013 till the date of providing the information.
 - (G) After providing the above information, please provide inspection of all records, documents, note-sheets and files relating to the information as referred to in point (A) to (F) above. Please provide inspection of complete file(s) even if they contain part of the information. Please note that I will undertake the inspection only if it is necessary in view of incorrect and incomplete information provided by you.
 - (H) Please provide list of files and records from which the information as sought above is provided by you.



- (I) Please provide copies of correspondence pages of the RTI file in which this application has been dealt with, till the date of providing the information. In case of correspondence emanating from me, only copy of first page of each document may be provided.
- (2) That the appellant vide para 5 of his said application has also made a declaration that the information sought for is not exempted under Section 8 or 9 of the RTI Act, 2005 and also stated that to the best of the knowledge of the appellant, the information pertains to the Office of the CPIO in question.
- (3) That Shri Rajender Prasad, CPIO & Accounts Officer has deliberately and malafidely not provided complete and correct information as sought by the appellant. The appellant being aggrieved by the said order of the CPIO is filing the present appeal.

GROUNDS OF APPEAL

- (1) That the order in question of the CPIO is incorrect and illegal and contrary to the provisions and sprit of the RTI Act, 2005 hence liable to be set aside.
- (2) That the information sought by the appellant is not exempted under Section 8 or 9 or any other provisions of the RTI Act, 2005, therefore, there was no valid cause or reason or ground for not providing the information.
- (3) That the Shri A. Mohan Kumar, Registrar and Deemed CPIO, Shri Mukesh Gupta Assistant Registrar (Admn.), Deemed CPIO and Incharge of the Computer Section, have deliberately and malafidely not provided any information though the RTI Application in question was forwarded and transferred to them on 4-6-2015. They may be directed to provide pointwise information to the appellant in time bound frame. They are liable for penal action for causing obstruction to the information without any reasonable cause. The appellant reserves his right to file direct complaint to the CIC, as the First Appellate Authority has no power to impose penalty.
- (4) That as per the various decisions of CIC and Delhi High Court, the CPIO



is required to file point-wise information. Despite such judicial pronouncements and clear statutory provisions, the CPIO and the Deemed CPIOs have deliberately and malafidely not provided point-wise information with a view to suppress the same and cause obstruction to the information without any reasonable cause.

- (5) That the CPIO has merely provided inspection of one file, whereas he has not provided the details of various information sought in Points (A) to Point (I) of the RTI Application. Mere offering one file for inspection is not substitute of providing the specific information as sought by the appellant. Therefore, the order of the CPIO in this respect is incorrect and illegal and liable to be set aside and the CPIO be directed to provide the information in time bound frame.
- (6) That the CPIO has erred in not providing the information to the appellant though as per the provisions of the RTI Act, the appellant is entitled to information as sought by him. Therefore, the order of the CPIO is liable to be set aside with direction to provide the information to the appellant within time bound frame.
- (7) That the information sought is neither voluminous nor relate to older and larger period, thus could have easily been provided by the learned CPIO.
- (8) That as per proviso to Section 8(1) of the RTI Act, 2005, the information which can not be denied to the Parliament or the State Legislatures shall not be denied to any person. The information sought by the appellant in the subject application is the one which cannot be denied to the Parliament or the State Legislatures and hence it cannot be denied or refused to the appellant.
- (9) That a personal hearing may be granted to the appellant before deciding the present appeal.
- (10) This is without prejudice to the right of the appellant to add, alter or modify any of the grounds of this appeal and adduce oral or written evidence at the time of hearing or till the appeal is disposed of.

PRAYER

Under the circumstances, the appellant prays as under:

(a) That the Original Records may be summoned and perused.

- (3)
- (b) That the order of the CPIO may be set aside to the extent it has been appealed against and CPIO/Deemed CPIOs may be directed to provide the information in question within time bound frame.
- (c) That imposition of penalty may also be recommended against the CPIO for not providing the complete and correct information.
- (d) That any other relief as the Appellate Authority deem fit and proper may also be ordered in favour of the appellant.
- (e) That a personal hearing may be granted to the appellant before deciding the appeal.







Thus being aggrieved by such refusal, this Appeal.

GROUNDS OF APPEAL

- (1) That the action of the learned CPIO and the deemed CPIO in not providing the information to the appellant is illegal and contrary to the provisions and sprit of the RTI Act, 2005.
- (2) That the information sought by the appellant is not exempted under Section 8 or 9 or any other provisions of the RTI Act, 2005 and therefore, there was no valid cause or reason or ground for not providing the information.
- (3) That the inaction of CPIO/Deemed CPIOs is in violation of Sections 7(1) and 7(2) of the RTI Act, 2005 and is therefore, illegal. Such inaction is deemed to be a refusal to the request of the appellant without any reasonable cause or ground hence is illegal.
- (4) That the information sought is neither voluminous nor relate to older and larger period, thus could have easily been provided by the learned CPIO.
- (5) That the appellant is citizen of India and fulfilled all other requirements of the RTI Act and the Rules made thereunder and is entitled to the information in question.
- (6) That as per proviso to Section 8(1) of the RTI Act, 2005, the information which can not be denied to the Parliament or the State Legislatures shall not be denied to any person. The information sought by the appellant in the subject application is the one which cannot be denied to the Parliament or the State Legislatures and hence it cannot be denied or refused to the appellant.
- (7) This is without prejudice to the right of the appellant to add, alter or modify any of the grounds of this appeal and adduce oral or written evidence at the time of hearing.
- (8) That a personal hearing may be granted to the appellant before deciding the present appeal.



(9) This is without prejudice to the right of the appellant to add, alter or modify any of the grounds of this appeal and adduce oral or written evidence at the time of hearing or till the appeal is disposed of.

PRAYER

Under the circumstances, the appellant prays as under:

- (a) That the Original Records may be summoned and perused.
- (b) That the CPIO may be directed to provide the information in question within a time bound frame.
- (c) That any other relief as the Appellate Authority deem fit and proper may also be ordered in favour of the appellant.
- (d) That a personal hearing may be granted to the appellant before deciding the appeal.



 - (B) Please provide list of all the files relating to tour and travel of CESTAT personnel for the years 2013, 2014 and 2015. Please provide copies of all the note sheets of the said file for the year 2014 and 2015. After providing the said copies, please also provide inspection of all the files and records relating to tour and travel including expenses incurred thereon.
 - (C) Please provide inspection of the Roaster File for the years 2014 and 2015.
 - (D) Please provide date-wise details of the action taken on the representations received from Shri J.K. Mittal Advocate. Please also intimate the file Nos. in which the said representations have been dealt with and provide copies of all the note sheets.
 - (E) Please provide date-wise details of the leave (all types including station leave and LTC) taken by Shri Rajendra Prasad, Accounts Officer, from 1-1-2013 till the date of providing the information.
 - (F) Please provide copies of the FAA's Orders of CESTAT New Delhi, Mumbai, Chennai, Kolkata, Ahmedabad and Bangalore from 1-1-2014 till the date of providing the information. Orders except those pertaining to the applicant i.e. Shri R.K. Jain, may only be provided.



- (G) Please provide copies of all note sheets and correspondence pages of the RTI file in which this application has been dealt with, till the date of providing the information. In case of correspondence emanating from me, only copy of first page of each document may be provided.
- (H) Please provide Daily Diary and Dak Diary/regular of, Shri Rakesh Kumar, Member (Technical), Smt. Archana Wadhwa, Member (Judicial) and Shri R.K. Singh, Member (Technical) from 1-1-2014 till the date of providing the information for CESTAT, Delhi
- (2) That the appellant vide para 5 of his said application has also made a declaration that the information sought for is not exempted under Section 8 or 9 of the RTI Act, 2005 and also stated that to the best of the knowledge of the appellant, the information pertains to the Office of the CPIO in question.
- (3) That Shri Rajender Prasad, CPIO & Accounts Officer has deliberately and malafidely not provided complete and correct information as sought by the appellant. The appellant being aggrieved by the said order of the CPIO is filing the present appeal.

GROUNDS OF APPEAL

- (1) That the order in question of the CPIO is incorrect and illegal and contrary to the provisions and sprit of the RTI Act, 2005 hence liable to be set aside.
- (2) That the information sought by the appellant is not exempted under Section 8 or 9 or any other provisions of the RTI Act, 2005, therefore, there was no valid cause or reason or ground for not providing the information.
- (3) That the CPIO and the Deemed CPIO has wrongly denied the information as sought in point (H) of the RTI application on the ground that Shri R.K. Singh did not exist in the organization from 1-1-2014. The appellant understands that Shri R.K. Singh joined CESTAT in May, 2014 and is still continuing, therefore the information in respect to Shri R.K. Singh should have been provided by the CPIO. Therefore, the order of the CPIO is

- liable to be set aside with direction to provide point-wise information to the appellant within time bound frame.
- (4) That the CPIO has erred in not providing the information to the appellant though as per the provisions of the RTI Act, the appellant is entitled to information as sought by him. Therefore, the order of the CPIO is liable to be set aside with direction to provide point-wise information to the appellant within time bound frame.
- (5) That the information sought is neither voluminous nor relate to older and larger period, thus could have easily been provided by the learned CPIO.
- (6) That as per proviso to Section 8(1) of the RTI Act, 2005, the information which can not be denied to the Parliament or the State Legislatures shall not be denied to any person. The information sought by the appellant in the subject application is the one which cannot be denied to the Parliament or the State Legislatures and hence it cannot be denied or refused to the appellant.
- (7) That a personal hearing may be granted to the appellant before deciding the present appeal.
- (8) This is without prejudice to the right of the appellant to add, alter or modify any of the grounds of this appeal and adduce oral or written evidence at the time of hearing or till the appeal is disposed of.

PRAYER

Under the circumstances, the appellant prays as under:

- (a) That the Original Records may be summoned and perused.
- (b) That the order of the CPIO may be set aside to the extent it has been appealed against and CPIO/Deemed CPIOs may be directed to provide the information in question within time bound frame.
- (c) That imposition of penalty may also be recommended against the CPIO for not providing the complete and correct information.
- (d) That any other relief as the Appellate Authority deem fit and proper may also be ordered in favour of the appellant.



(e) That a personal hearing may be granted to the appellant before deciding the appeal.
