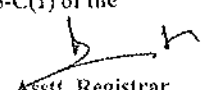

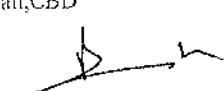

Appeal is disposed of as withdrawn under litigation policy as prayed in Application, without entering into merits. Cross Objection also stands disposed of.

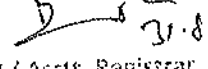
