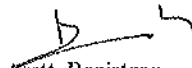

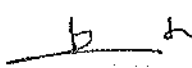

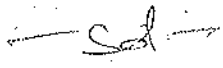

Appeal is disposed off as withdrawn under litigation policy as prayed in M.A. No. 70315/2016, without entering into merits.

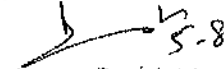
