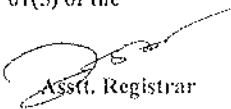

After hearing both the sides, I find that the Commissioner (Appeals) has rejected the appeal on the ground of time bar by observing that there was a delay of 3 years, 4 months in filing the appeal before him and he has no jurisdiction to condone the delay.

2. The issue is no more *res-integra* and stands settled by the Supreme Court's decision in the case of M/s. Singh Enterprises Vs CCE Jamshedpur reported at 2008 (221) E.L.T. 163 (SC) laying down that the Commissioner (Appeals),

being a creature of the Statute, has no power to act beyond the power confirmed by the Act. As Section 35B empowers the Commissioner (Appeals) only to condone the delay of 30 days, he cannot condone the delay beyond the said period.

4. Inasmuch as the issue stands decided, I find no infirmity in the impugned order of Commissioner (Appeals), and accordingly, the appeal filed by the appellant is rejected.
