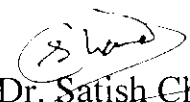

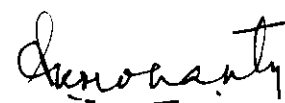

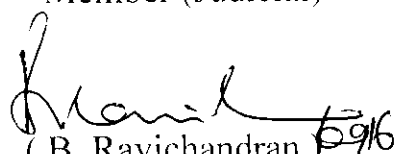
Ms. Reena Khair, Id. Counsel for the appellants prays for withdrawal of the appeals. Other parties have no objection.
