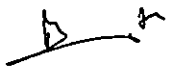

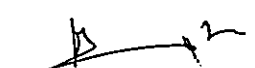

Heard both sides. Considering the grounds in the condonation application, the delay in filing the appeal is condoned. We note that the lower appellate authority has dismissed the appeal on the ground of non compliance with the direction of depositing the entire amount of duty. Considering the financial difficulty ^{pleaded} by the appellants on account of closure of the factory, we direct the appellants to pre-deposit 25% of duty amount within four weeks and report compliance to the lower appellate authority. Subject to compliance of the above direction, the

impugned order shall stand set aside and the appeal remanded to the lower appellate authority. ^{In the event of} Non compliance of the above direction, the appeal shall stand dismissed.
