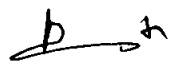

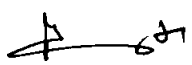

Per M. Veeraiyan:

These four appeals No.E/321, 322, 323 and 324 of 2006 arise out of common order. The disputed amounts involved in one case is a penalty Rs.4,338/- and redemption fine of Rs.1000/-and in other three cases, a penalty of Rs.1,000/- each. Considering the quantum of disputed amounts

involved, these appeals are dismissed in terms of the proviso (2) to Section 35B of Central Excise Act, 1944 as the amounts involved are very meagre.
