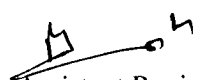

Per S.S.Kang:

Heard both sides. The revenue filed this appeal against the impugned order whereby Commissioner(Appeals) held that respondent being recipient of consulting service who is residing outside India and having no office in India, is not liable to pay service tax. ^{SS-1}
^{for the period 1998-99 to 2002-03} We find that this issue is covered by the Larger Bench decision of the Tribunal in the case of Hindustan Zinc Ltd. vs CCE reported in 2008(87)RLT.317. The Tribunal held that the taxable service provided by non-resident from outside India who does not have any office in India, having been specified as 'taxable service' w.e.f. 1.1.05 and recipient of such service could not be held liable for paying service tax prior to 1.1.05. In view of the above decision, we find no infirmity in the impugned order. The appeal is dismissed.
