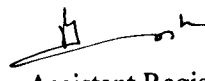

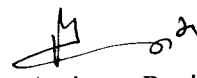

Per D.N. Panda :

Ld. Counsel Shri Akash Tyagi argues that although Id. Commissioner (Appeals) has reduced penalty to Rs.40,000/-, there is still no case for Revenue for such imposition. Therefore the appellant has carried the matter to Tribunal being aggrieved by the impugned order.

2. Ld. DR appearing on behalf of the Revenue supported order of Authority below.

3. In the course of hearing, we have found that Id. Commissioner (Appeals) was very lenient to reduce the penalty but he was unable to conceive that there was no evasion. Therefore he has used his discretion for grant of reduction of penalty. There is no appeal from Revenue nor also a cross-objection. In absence of any appeal or cross-objection filed by Revenue, a relief granted by the lower authority cannot be disturbed and accordingly we dismiss the appeal.
