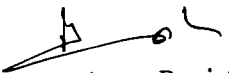

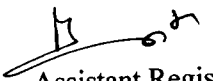

Per D.N. Panda:

Ld. DR submits that the present Misc. application is to rectify the mistake committed by Revenue at the time of filing appeal with authorisation of only one Commissioner. By the present application, they are submitting authorisation signed by two Commissioners. When verified, that shows that the Commissioners have signed the document on two different dates. While Commissioner of Delhi-III has signed authorisation on 12.2.09, the Commissioner of Rohtak has signed on 13.2.09.

2. Ld. Counsel Shri Narasimhan appears today on behalf of Respondent and he submits that the factual position noticed by the Bench is proper. However, he says that the litigation having involved a small amount, there is jurisdiction of single bench, exercisable.

3. When we look at the title page of the authorisation, we find no date of issue of Authorisation so far. The COD application was allowed to provide an opportunity of hearing to the appellant Revenue to pursue its remedy. Their casual approach is apparent from the record itself. This shows lack of interest of Revenue to pursue the remedy. The appeal has involved litigation for Rs.26,000/-. Considering the matter from all angles as aforesaid, we dismiss the appeal being made for a meagre amount in dispute which also appears to be abuse of the process of law. We dispose the Misc. application and also dismiss the appeal.
