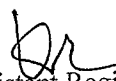

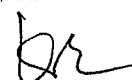

ORDER

Per. D.N. Panda :-

Learned Counsel moved an application for early hearing of the matter. His grievance is that a refund of Rs. 26,00,000/- being involved and the appellant failing to succeed before both the authorities below, early hearing may be granted.

2. Learned DR Shri A.K. Madan submits that revenue has no grievance for early hearing. But the appellant having failed to satisfy the authorities below about its claim of refund, It has failed to get the same. Learned Commissioner (Appeals) has remanded the matter to

grant an opportunity of hearing by the learned Adjudicating Authority. When the matter is remanded, the appellant has come to Tribunal to oust jurisdiction of the learned ~~Appellate~~^{Adjudicating} Authority.

2.1 Heard both the sides and perused the records.

2.2 We appreciate submission of the learned DR and also have gone through the first appellate authority's order. The learned Commissioner very leniently considered that the appellant deserves an opportunity of hearing before the learned Adjudicating Authority to adduce evidence for its claim and satisfy that Authority against findings made in the order of the learned Appellate Authority below. We, therefore, direct the appellant to appear before the learned Adjudicating Authority and satisfy him as to the requirement of law and its claim for refund. It would be proper for the appellant to appear before the learned Adjudicating Authority on **15th April 2009** to satisfy that authority as to its claim. If the appellant fails to appear before that authority on the day fixed as above, the learned Adjudicating Authority is free to decide the matter on its own merit.

3. In the result, both the miscellaneous application and appeal are disposed of in the manner stated above.
