Per D.N. Panda :

The limited issue in this Appeal is whether contemporaneous evidence gathered by Revenue should be confronted to the Appellant ^{to lead its} defence. Ld. Counsel Shri A.K. Mishra submits that there was no difficulty for the Appellate Authority to confront the Bill of Entry No. 220 dated 24.1.2006 and Bill of Entry No. 481256 dated 19.1.2006 for appropriate answer by the Appellant following principles of natural justice. Therefore the matter should go back to

○ Id. Appellate Authority below for confrontation of the contemporaneous evidence as above and dispose the matter in accordance with law.

2. Ld. DR Shri Sansar Chand agrees that there is contemporaneous evidence used against the Appellant and also agrees that there was no confrontation of the documents above for the difficulties of the Appellant.

3. Heard both sides and perused the record.

4. Appreciating that the aforesaid issue was only bone of contention of both the sides. It would be proper to remit to the Id. Appellate Authority below to grant fair opportunity of hearing confronting the Bill of Entries aforesaid to the Appellant and considering entire pleading of the Appellant, reasoned and speaking order shall be passed in accordance with law.

5. In the result, the impugned order is set aside by way of remand.
