FINAL Oral Order No. 1263 / 09-EX

Per M. Veeraiyan:

This is an appeal against the order of the Commissioner No. 58-59/05 dated 28.11.2005.

2. Heard both sides.

3. The dispute in this appeal relates to the valuation of chewing tobacco under the brand name of 'Raja Khaini' in pouches of 5 gms. and 9 gms. as to whether the same should be assessed in terms of Section 4A or in terms of transaction value under Section 4. Both sides agree that the very same

issue relating to the same appellant has been decided in favour of the party vide Final order No.429/2009-EX dated 17.6.09 in Appeal No.E/37/2005.

4. In view of the above, the present appeal involving the same issue deserves to be allowed and accordingly, the same is allowed with consequential relief, if any, as per law.
