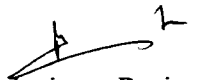

The Respondents are not present.

2. Heard the learned DR. He confirms that the lower Appellate Authority has remanded the matter for re-quantification of the duty amount.

3. In the light of the facts and circumstances of this case, we find that the ^{duty} requires re-quantification and hence the same is required to be done at the Original Authority's level. Accordingly, we dispose of the appeal directing that the matter should be decided afresh by the Original Authority after giving adequate opportunity of hearing to the respondent.
