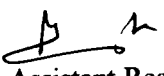

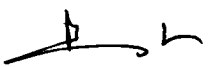

Per D.N. Panda:

Though the appeal was decided by the first appellate authority on merits that was unwarranted as the appeal before him was suffering from limitation. When the dates stated before us showing that the order was received on 25.06.2002 and the appeal was filed on ^{30.10.2002 while} ~~...~~ and the limitation expired on 24th August, 2002. The appeal before the Commissioner (Appeals) was filed on 30th October, 2002. When the appeal crossed its limitation that was not

maintainable before him for which that should have been dismissed. Therefore, for ^{non} maintainability of the appeal and the Tribunal having no power to condone the delay in filing the appeal before Commissioner (Appeals), this appeal stands dismissed.
