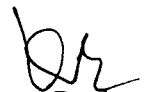

Per D.N. Panda:

The order challenged by Revenue indicates that without any reason being spoken by the order, Ld. Commissioner (Appeals) waived the penalty of Rs.50,000/- imposed on the respondent.

FINAL ORDER No. 519/2011 SM (BV)

Once reason for waiver is not given on the order, that order suffers from legal infirmity and lacks judicial propriety. It is not expected from the Appellate Authority to make a mechanical disposal of the appeal discussing the case of some other party at para 4 of the impugned order. Therefore, the matter is remanded back to the Commissioner(Appeals) to grant fair opportunity for hearing to the respondent and pass appropriate order.
