This appeal has been filed by the Revenue against Order-in-Appeal No. 40/HAL/2007 dated 26.10.2007 passed by the Commissioner (Appeal-I), Central Excise, Kolkata.

2. Shri. S. S. Chattopadhyay, Suptd. (AR) appeared on behalf of the Revenue and reiterated the grounds of appeals.

3. Heard both sides and perused the appeal records.

4. We find that though the amount involved in this matter is Rs.6,40,380/- which is below the mandatory limit of Rs.10.00

lakhs in terms of Board's instruction F. No. 390/Misc./163/2010-JC dated 17/08/2011, the present case falls under exclusion clause 3 (c) of the National Litigation Policy introduced vide Board's instruction dated 17.12.2015 which has been deleted vide instruction F. No. 390/Misc./115/2017-JC dated 04.04.2018.

4. Accordingly, the appeal is dismissed.
